David Scanlan, Secretary of State Adam Boltik, BEA Chase Hagaman, BEA Meeting called to order at 1:00 PM by Commissioner Taylor Caswell

Introduction of Council Members and guests

Senator Birdsell provided a readout on a trip to Ireland in August 2024.

- Delegation included local government officials from several states
- Trip included visits to Dublin, Ireland, and Belfast, Northern Ireland.
- Identified important U.S. Ireland ties in investment (Ireland is a significant investor in the U.S.) and education
- Meetings included the Irish Government (Department of Foreign Affairs, the Dail), U.S. Government (U.S. Ambassador to Ireland Claire Cronin), and businesses (American Chamber of Commerce in Ireland, Google)

Commissioner Caswell provided a readout on a trip to Ireland by Governor Sununu and a small delegation in September 2024

- Delegation included leadership from the Department of Business and Economic Affairs and the Governor's office
- Identified specific partners and follow-up opportunities for the Council to build economic and educational ties and relationships
- Meetings included the Irish Government (Department of Foreign Affairs, the Dail, Enterprise Ireland), U.S. Government (U.S. Ambassador to Ireland Claire Cronin and Embassy staff), businesses (American Chamber of Commerce in Ireland, Keogh's Crisps), and potential partners (The Mill Enterprise Hub, AMBER Research Centre at Trinity College)

Council members discussed potential areas of work, including:

- Identifying opportunities to engage Irish students in NH businesses through internship programs (such as with ARMI) and potentially exploring license reciprocity
- Strengthening travel links between Ireland and NH such as through Manchester -**Boston Regional Airport**

- Boost the recognition of New Hampshire in Ireland and engaging more with visiting trade delegations and officials, such as inviting official visitors to New Hampshire when they might be visiting Boston (such as over St. Patrick's Day).

Senator Sharon Carson was elected Chair of the New Hampshire - Ireland Trade Council

Council members discussed next steps, including:

- Meeting on a monthly basis (except for December) to continue to identify opportunities in education, tourism, and business partnership development
- Identifying specific focus areas, including in key sectors of life sciences, aerospace, and advanced manufacturing where there are some synergies
- Reaching out to invite New Hampshire's Federal delegation to meetings as well as representatives from Ireland in Boston (including the Consul General and Enterprise Ireland)
- Putting together a website, either with the Secretary of State's office of the
 Department of Business and Economic Affairs, for the Council to post agendas and
 minutes as well as to highlight history between New Hampshire and Ireland.
